Complications of Pregnancy Benefit – up to a maximum of \$1,000,000

Accidental Death and Dismemberment – \$100,000

Air Ambulance – up to a maximum of \$5,000

Acts as primary coverage for Complications of Pregnancy when no other coverage applies, otherwise benefits are paid on an excess basis

Hospital Maximum - \$1,200 per day up to 30 days

In-Hospital or doctor ordered Weekly Bed Rest Disability Benefit

Coverage for Non-elective C-sections subject to a \$10,000 deductible

Coverage for post-partum depression subject to a \$1,000 deductible

No deductible for all other benefits
